Vendor Booth Information and Responsibilities

*Plus a \$50 refundable cleaning deposit that will be returned to you at the end of the festival after the vendor chairman has inspected your booth to ensure that it has been cleaned.

For those vendors using trailers, the size of the trailer will have to be approved by the Vendor Chairman.

If selling a product, you are expected to pay an agreed upon percentage of your gross receipts to the festival, such percentage being set forth on the application to which this exhibit is attached. The booth rental will be deducted from this percentage.

For example: Gross Receipts = \$10,000 X 15%= \$1500.00 - \$600 (booth fee) = \$900.00 final payment to Rock The Desert Ministries, Inc

One electrical outlet wired with 110V electricity with 4 plugs will be provided for each booth. If you will need 220V, or if you need another 110V setup there will be a \$50 charge.

Set up time for vendor booths will be **Thursday, August 7th, from 8AM to 5PM**. All booths are required to open to the public at **3PM on Friday**. Operating hours will be Friday, 4PM to 12AM, Saturday, 10AM to 12AM. Vendors will not tear down until Sunday.

5 event tickets will be given to each vendor booth. Additional tickets maybe purchased for all other volunteers or workers.

Vendor agrees to sell only those food/drink items set forth in the application to which this exhibit is attached. Rock the Desert is the approved vendor for all soft drink and water sale. Should vendor bring in any items to sell not set forth in the attached application, then Vendor's rights hereunder shall immediately terminate and Vendor will not be permitted to make any further sales. In the event of such termination, Vendor shall nevertheless perform its remaining obligations hereunder.

All vendors are responsible to collect and pay any required local and state taxes.

All vendors will provide a Certificate of Liability Insurance with a minimum amount of \$1 million naming Rock the Desert Ministries, Inc. as additional insured. Please submit your application as soon as possible as the festival gets many applications and has limited space. Any application received after **May 31, 2008**, deadline may not be considered. Upon receipt and acceptance of this application the festival management will return your copy of contract. The festival will send back notification of acceptance to all vendors.
